## **Big Data: Managing ESI in Construction Cases**

Construction projects often last several years, involve multiple parties, and result in significant amounts of communication. The result is often very large amounts of electronically stored information ("ESI") related to the project. If there is litigation, discovery can often involve sorting through thousands if not millions of documents. The U.S. Supreme Court's landmark ruling in *Daubert v. Merrell Dow Pharmaceuticals, Inc.* in 1993 established a standard for the admissibility of expert testimony in federal courts. As a result of the *Daubert* decision, financial experts are required to provide a more rigorous and reliable basis for their opinions, and their methodologies and techniques must be supported by established scientific principles, empirical data, and peer-reviewed literature.
