



Fall Seminar COVID Policies 2021

We believe the majority of our members, as legal professionals, are fully vaccinated. Masks are optional for vaccinated individuals at NCADA indoor and outdoor sessions. Proof of vaccination is not required. However, if you are not fully vaccinated, you are invited to join us virtually for your safety and others. Unvaccinated individuals are requested to wear masks in meeting and event spaces during the conference.

Before the meeting for all attendees

- Assess you are not experiencing any [symptoms of COVID-19 as identified by the CDC](#). If you are experiencing symptoms, please get tested and attend virtually.
- If you came into close contact with someone with COVID-19, please get tested 3-5 days after the date of your exposure and wear a mask in public indoor settings for 14 days after exposure or until a negative test result.
- Isolate if you have tested positive for COVID-19 in the prior 10 days or are experiencing [COVID-19 symptoms](#).
- **Do not attend if you meet any of the above listed precautions.** Registration refunds will be given in full or in part based on the registration fee paid. You will also be given the option to attend virtually at the appropriate registration fee for members, non-members, and guests.

What to Expect On-Site

Learn about [Omni Safe and Clean practices](#) at the Omni Hilton Head. Please adhere to hotel mask policies in the public and common areas of the resort.

Room setups for seminars, meal functions, exhibit areas will be modified from our traditional setups to remain mindful of social distancing and health measure recommendations.

In addition to hand sanitizer stations provided throughout the property by the hotel, NCADA will provide individual sanitizer wipes and pump bottles for each exhibitor station. NCADA will have extra masks available and will provide a shopping bag for miscellaneous handouts and promotional items to limit touching. Don't forget to wash your hands!


NCADA will provide wrist bands for attendees to wear when out and about in the Resort so we can easily recognize members of our group in order to better maintain our COVID-free bubble.



Personal Boundaries


Please keep in mind the varying levels of individual comfort and respect those who wish to wear a mask; keep the distance; avoid hugs and handshakes; use a fist or elbow bump, a bow or curtsy, etc. Color-coded stickers to indicate an attendee's personal comfort level will be provided with name badges:



I am comfortable interacting with others; using normal conference engagement - "Give me a hug!"



I am comfortable interacting with others but would prefer you stay 4-6 feet away and I might be wearing a mask - "Prefer a fist bump over a hug"



I am not comfortable interacting with others but didn't want to miss the conference experience. Please social distance with me and accept that I will be wearing a mask.
