## **Guidelines for Contributions**

**The Resource**, the monthly NCADA e-newsletter, showcases resources, information and topical articles of interest to the members of the NCADA. To achieve these ends, as a service to you, and to help us present information to your fellow members in a professional, well-organized, easy to digest format, we have developed these brief guidelines.

The Resource topical areas – Overview and Guidelines for Submission

- Appellate Cases of Note. This section includes a partial synopsis of notable cases, highlighting NCADA members as applicable either involved or commenting on the case. Contributor(s) will provide short descriptive paragraph with link to appellate case decisions. Format:
  - Draft synopsis in Microsoft Word format;
  - Single space, with one space between paragraphs;
  - Limit synopsis to no more than 100 words with links to relevant opinion;
  - Include heading for opinion synopsis;
  - Contributors are responsible for the accuracy and completeness of citations and quoted material.
- Verdicts & Rulings of Note. This section shares our members successful verdicts providing a partial synopsis of the verdict/ruling, highlighting NCADA member. Contributor will provide short descriptive paragraph with relevant links.
  - Draft synopsis in Microsoft Word format;
  - Single space, with one space between paragraphs;
  - Limit synopsis to no more than 100 words with links to relevant opinion;
  - Include heading for opinion synopsis;
  - Contributors are responsible for the accuracy and completeness of citations and quoted material.
- **Featured Article**. Members are invited to submit articles along with regular features from NCADA Practice Groups.
  - Draft synopsis in Microsoft Word format;
  - Single space, with one space between paragraphs;
  - Feature articles are limited to 1,000 to 1,500 words;
  - Use underline for e-mail and website links only. Use Italics to emphasize;
  - Check and verify names before submission.
  - Keep citations to a minimum, links embedded within text;
  - No footnotes, endnotes only;
  - Contributors are responsible for the accuracy and completeness of citations and quoted material.

- Legislative & Regulatory News. This section will provide partial synopsis of important legislative and regulatory changes, news and rules impacting members practices. Contributor will provide short descriptive paragraph with relevant links.
  - Draft synopsis in Microsoft Word format;
  - Single space, with one space between paragraphs;
  - Limit synopsis to no more than 100 words with links to relevant opinion;
  - Include heading for opinion synopsis;
  - Contributors are responsible for the accuracy and completeness of citations and quoted material.
- **Members and Firms of Note.** This section will provide a monthly highlight of a randomly selected member and/or firm.
